ANNOUNCEMENT OF EXTRAORDINARY GENERAL MEETING OF KEPPEL REIT TO BE HELD ON 24 FEBRUARY 2021

- Background:** Keppel REIT Management Limited, as manager of Keppel REIT (the "**Manager**"), refers to:
 - the Notice of Extraordinary General Meeting dated 29 January 2021, which is published on Keppel REIT's website at <https://www.keppelreit.com/investor-relations/agm-and-egm> and on SGXNet ("**Notice of EGM**");
 - the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for the conduct of general meetings, either wholly or partly, by electronic communication, video conferencing, teleconferencing or other electronic means; and
 - the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "**Order**") which was gazetted on 13 April 2020, and the Joint Statement by Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore, and Singapore Exchange Regulation in relation to Guidance on the Conduct of General Meetings Amid Evolving COVID-19 Situation issued on 1 October 2020, which set out the alternative arrangements in respect of, *inter alia*, general meetings of real estate investment trusts.

- Date, time and conduct of Extraordinary General Meeting:** The Manager wishes to announce that pursuant to the Order, the Extraordinary General Meeting of Keppel REIT ("**EGM**") will be convened and held by way of electronic means on **Wednesday, 24 February 2021 at 3.00 p.m. (Singapore Time)**, for the purpose of seeking the approval of unitholders of Keppel REIT (the "**Unitholders**") for the proposed acquisition of Keppel Bay Tower through the acquisition of shares of Keppel Bay Tower Pte. Ltd., as an interested person transaction (further details of which are set out in the circular to Unitholders dated 29 January 2021 (the "**Circular**")).

The Manager's Chairman, Mrs Penny Goh, the Chairman of the Audit and Risk Committee, Mr Lee Chiang Huat, the Chief Executive Officer, Mr Paul Tham and the Deputy Chief Executive Officer, Ms Shirley Ng, will conduct the proceedings of the EGM.

- Issuance of Circular:** The Manager has today issued the Circular which contains, *inter alia*, details of the resolution to be tabled at the EGM and a Notice of EGM.

The digital version of the Circular is also available on the website of Singapore Exchange Securities Trading Limited (the "**SGX-ST**") at <https://www.sgx.com>. Printed copies of the Circular will **not** be sent to Unitholders.

- Notice of EGM and proxy form:** Printed copies of the Notice of EGM and proxy form will be sent to Unitholders. The Notice of EGM and proxy form are also available on Keppel REIT's Website. Unitholders may view and download the Notice of EGM and proxy form through this website link: <https://www.keppelreit.com/investor-relations/agm-and-egm> and on SGXNet.
- No personal attendance at the EGM:** A Unitholder will **not** be able to attend the EGM in person.

6. **Participation at the EGM electronically:** Unitholders may participate at the EGM by:
- (a) observing and/or listening to the EGM proceedings via “live” audio-and-visual webcast via their mobile phones, tablets or computers or “live” audio-only stream via telephone;
 - (b) submitting questions in advance of the EGM; and
 - (c) appointing the Chairman of the EGM (being Independent Director, Mr Lee Chiang Huat) ("**Chairman of the EGM**") as proxy to attend, speak and vote on their behalf at the EGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the EGM are set out in the **Appendix** to this announcement.

7. **Persons who hold Units through relevant intermediaries:**

- (a) Persons holding units in Keppel REIT ("**Units**") through Central Provident Fund ("**CPF**") and Supplementary Retirement Scheme ("**SRS**") ("**CPF/SRS investors**") who wish to participate in the EGM by (i) observing and/or listening to the EGM proceedings via “live” audio-and-visual webcast or “live” audio-only stream; and (ii) submitting questions in advance of the EGM, should follow the steps for pre-registration and pre-submission of questions set out in the Appendix. However, CPF/SRS investors who wish to vote should approach their respective CPF Agent Banks or SRS Operators to submit his/her vote by **5.00 p.m. on 15 February 2021**, being 7 working days before the date of the EGM.
- (b) Persons holding Units through relevant intermediaries (other than CPF/SRS investors) who wish to participate in the EGM by (i) observing and/or listening to the EGM proceedings via “live” audio-and-visual webcast or “live” audio-only stream; (ii) submitting questions in advance of the EGM; and/or (iii) appointing the Chairman of the EGM as proxy to attend, speak and vote on their behalf at the EGM, **should contact the relevant intermediary through which they hold such Units as soon as possible in order to make the necessary arrangements for them to participate in the EGM.**

A “**relevant intermediary**” means:

- (i) a banking corporation licensed under the Banking Act, Chapter 19 of Singapore, or a wholly-owned subsidiary of such a banking corporation, whose business includes the provision of nominee services and who holds Units in that capacity;
- (ii) a person holding a capital markets services licence to provide custodial services for securities under the Securities and Futures Act, Chapter 289 of Singapore, and who holds Units in that capacity; or
- (iii) the Central Provident Fund Board ("**CPF Board**") established by the Central Provident Fund Act, Chapter 36 of Singapore, in respect of Units purchased under the subsidiary legislation made under that Act providing for the making of investments from the contributions and interest standing to the credit of members of the Central Provident Fund, if the CPF Board holds those Units in the capacity of an intermediary pursuant to or in accordance with that subsidiary legislation.
